## **A Message from the Chair**

IFLA Acquisition and Collection Development Section has 149 members all over the world. The number has remained quite stable during last years. Some things change, and the year 2003 meant many changes for the Section.

New strategic plan 2004-2005 was discussed in Berlin conference and was accepted by the Professional Committee in its December 2003 meeting. The strategic plan is much influenced by IFLA's new president Kay Raseroka's presidential theme "Life-long Literacy" and the themes of two next World Library and Information Congresses. The theme of Buenos Aires 2004 is "Libraries: Tools for Education and Development".

Starting from Buenos Aires each section has only one programme and it can take only 2 hours. The Section decided to have a programme by the title: "Collection for literacy and development: focus on Latin America". Hopefully many members of the Section can attend the first IFLA conference held in South America.

An important change was the closing of Universal Availability of Publications – UAP-programme, which has been very important for the Section. This hopefully will not cause problems for the Section and all planned activities will be realized.

In the Section there were also some changes. The standing committee got 8 new members, and there are now 22 members and 2 corresponding members representing 13 countries. New officers were elected: Pentti Vattulainen as the chair and Lynn Sipe as the secretary. As Lynn may not be known to the members, I attach some of his work life details. Lynn has spent his entire career at the University of Southern California. Current responsibilities are as head of technical services, coordinator of collection development and associate dean, faculty affairs. Lynn has been active in collection management & development section of ALA, including as its chair. He also serves as an OCLC western delegate to OCLC members' council and he is treasurer of the California's Consortium of Private Academic Libraries. He is a board member and regular volunteer at ONE institute & archives in Los Angeles, the world's largest gay & lesbian archive/library.

Lynn has compiled this newsletter, which is full of formal matters: minutes and reports. We are going to develop the newsletter, so that there will be already in the next issue more editorial material, which hopefully interests the members. We hope that members are active and inform us of any interesting news or events connected to acquisition and collection development. ## **IFLA Munich Pre-Conference Summary Report**

The IFLA Pre-Conference “Is digital different? – New trends and challenges in acquisition and collection development”, organised by the IFLA Section of Acquisition and Collection Development and the Bavarian State Library, took place in Munich, the capital city of Bavaria, Germany, from 30 – 31 July 2003. The auditorium in the headquarters of the Goethe Institut was the primary venue for the sessions.

A detailed schedule of the programme of the Pre-conference was previously published in Issue No. 27 (Summer 2003), pp. 10-11, of the Acquisition and Collection Development Section’s *Newsletter*.

The conference, which was attended by about 130 participants, focused on the question of how principles of acquisition and collection development change in the digital age. International experts, representing different segments of the information chain, examined the validity of traditional selection criteria in the digital world. Case studies gave first-hand information on how the hybrid collection can be organised in terms of creating user-oriented access points as well as the internal restructuring of work-flow processes. Papers and panel discussions explored current trends in acquisition policy for the hybrid library, such as the value of consortia building and the importance of constant evaluation by setting up standards for measuring usage, in particular against the background of emerging changes in the publishing world. In addition new approaches to scholarly communication related to the current open access discussion were presented.

In the evening of the first conference day, a festive buffet dinner was held in the so-called Princes’ hall of the Bayerische Staatsbibliothek. Conference participants were also given the chance to feast their eyes on an exhibition of the most important medieval treasures of the library.

The Munich conference was a great success due to its high-quality papers, lively discussions and its pleasant atmosphere, as the very positive feedback of many participants showed.

The Standing Committee met twice during the Annual IFLA Conference in Berlin. The first meeting was held on Saturday 2<sup>nd</sup> August 2003 at 11.30-14.20 and the second on Friday 8<sup>th</sup> August 2003 at 10.15-12.15. These minutes cover both meetings.

**1. Attendance and general introductions**

After each participant had introduced him/herself Nancy Davenport as Chair welcomed all participants, especially new members of the Standing Committee. She also noted that the observers were allowed to contribute to discussions. The business would be conducted in English.

**2. Adoption of the agenda**

The agenda was approved as proposed.

**3. Adoption of the minutes from Standing Committee meetings in  
Glasgow**

The minutes of the Glasgow meetings were approved as written.

**4. Election of the Chair/Financial Officer**

Elections were held at the beginning of the first meeting for the offices of Chair and Secretary. The continuing and incoming members were eligible to nominate, be nominated and vote in the elections.

There was only one candidate for Chair/Financial Officer and Pentti Vattulainen was elected by acclamation as the Chair.

## **5. Election of the Secretary/Information Coordinator**

As there were two candidates – Klaus Kempf and Lynn Sipe - a secret ballot was conducted under the auspices of the officers. The result of the ballot was draw. After Klaus Kempf withdrew Lynn Sipe was nominated as the Secretary /Information Coordinator.

## **6. Acquisition and Collection Development events at the Berlin Conference**

### **6.1. Open Programme**

Pentti Vattulainen summarised the content of the Open Programme to be held on Sunday morning. The Open Programme would be on book donations and gifts. It would contain four papers: from Australia, USA, Kazakhstan and Senegal. The last paper would be in French, others in English. All were on IFLANET.

### **6.2. Workshop**

Pentti Vattulainen described the workshop, which was scheduled for Thursday morning. The workshop would focus on co-operative collection development. The panel of presenters would describe recent developments in Scotland, Germany and North America. The fourth talk would be on automated approach to collection assessment developed by OCLC.

### **6.3. IFLA Booth**

The chair asked volunteers to represent the Section at the IFLA booth on Tuesday 5<sup>th</sup> August 11.00-12.00. Nancy Davenport, Klaus Kempf and Pentti Vattulainen volunteered to be at the stand.

## **7. Reports from other meetings**

7.1. Nancy Davenport reported on some highlights from the first meeting of the Division V Coordinating Board from Friday 1<sup>st</sup> August.

- The organisers informed about the conference preparations and all signs show that this should be a successful conference.
- Social Responsibility Discussion Group has given some recommendations that should be discussed in Standing Committee meetings (see minute 8 below).
- President-elect Kay Raseroka has a special session on Wednesday, August 6. The session will be organized by divisions so that the discussion at each table can focus on ways in which each Division and its sections can reflect Kay's theme, "Libraries for Life-long Literacy," in their strategic plans and programs for the 2003-2005 period. SC members are encouraged to attend this session.
- The Professional Committee has decided that it would carry out a thorough review of IFLA Sections in 2007. It agreed to do this in the light of the recent increase in the number of Sections, arising from the decision to translate a number of former Discussion Groups into Sections, and the later decision to translate most of the former Round

Tables into Sections. The Committee invites Standing Committees to review their objectives and the means available to achieve them. The Committee has not yet set out any criteria for the review.

- Instructions for Buenos Aires (see minute 12 below).

7.2. Klaus Kempf reported on the Munich satellite meeting "Is digital Different: New trends and challenges in acquisition and collection development". IFLA Acquisition and Collection Development Section and Bavarian State Library sponsored the meeting. The dates were 30-31 July 2003. There were 150 participants. The meeting was a success. Klaus Kempf will provide more information about the meeting to the Section's newsletter.

7.3. Ann Okerson informed about the Publisher Relations Advisory Committee (PRAC) meeting, which was scheduled for Sunday morning. PRAC was established to assist the Secretary General of IFLA in his negotiations with International Publishers Association (IPA).

## **8. Recommendation of the IFLA Social Responsibility Discussion Group**

During a range of years, the IFLA Social Responsibilities Discussion Group (SRDG) has been actively organising and holding an ongoing discussion during IFLA General Conferences. The DG's Convenor Alfred Kagan submitted a Final Report of the SRDG in the course of September 2002, which was accompanied by 13 Recommendations, a list indicating to which IFLA bodies specific recommendations would have to be directed, and a draft reworking of IFLA's Professional Priorities showing the connection to these Recommendations. All these documents were discussed at the Professional Board's meeting in December 2002. During ample deliberations, a number of Sections were added to the suggested list of IFLA bodies to receive the recommendations. The following recommendation was forwarded to Acquisition and Collection Development Section:

*5. IFLA should work with commercial information providers to establish a standard price structure for publicly supported libraries based on ability to pay.*

The Standing Committee discussed about the recommendation. The SC agreed that this is an important initiative. The DG's Convenor Alfred Kagan was present in the meeting and he stressed that the recommendation was not about donations but about on-going materials.

The SC noted that there were 5 sections that received the same recommendation. It was proposed that there should be an intersectional committee to clarify what could be done. It was finally decided to continue the issue in the next SC meeting.

## **9. Report of the Financial Officer**

No money used during the year. The money shall be transferred to the new Financial Officer before 1<sup>st</sup> October.

## 10. Activities of the Standing Committee

### 10.1. Projects

#### 10.1.1. Acquisition bibliography

The section has kept a bibliography on acquisition matters in IFLANET. It still gets some additions. The problem is that the bibliography is just a list of records and it does not have a database structure. It is quite difficult to use. It was agreed that the secretary will contact IFLANET administration to check if the database structure could be developed. This would be continued in the next meeting.

#### 10.1.2. Handbook for the International Exchange of Publications

A new edition of the Handbook for the International Exchange of Publications was proposed in 1999. The Handbook was originally planned to be prepared in the French National Library. The content was planned to consist of two parts: a directory and a "narrative" part. The latter would contain articles from various parts of the world (papers from Boston IFLA workshop), history of international exchanges, agreements etc.

The IFLA Professional Board allocated some funds for the project. K G Saur promised to publish the Handbook.

After the French National Library gave up the project, Pentti Vattulainen promised to try to do something with it. Preparations are still going on. According to the timetable the publication should be out during this year.

#### 10.1.3. Section Brochure

Lynn Sipe has made a draft, which was delivered to SC members. He expects comments from the members before the next meeting.

#### 10.1.4. Repository Library Conference "Kuopio 2"

Pentti Vattulainen proposed this to be a project, which the Section would sponsor. The conference would be held in Kuopio, Finland in May 2004 (probably 13<sup>th</sup>-16<sup>th</sup> May). The previous repository library conference was held in Kuopio in 1999. It was organised by the National Repository Library of Finland, Center for Research Libraries and Kuopio University Library, and sponsored by the UAP programme of IFLA and NORDINFO.

Pentti proposed the title "*How to preserve and keep available print resources - the role of repositories*". This could include e.g. the following sub-themes:

- Cost of access (print, electronic resources) can repositories cause cost reductions?
- Preservation of print copies of electronic resources (national, regional, other level)
- Participation in preserving national print resources.

The SC approved the proposal. A planning group was established and the following members volunteered to participate in it: Pascal Sanz, Klaus Kempf, Lynn Sipe and Christine Friström.

#### 10.1.5. Donations guidelines

Professional Committee member Rashid Begum visited briefly in the SC meeting and proposed that the Section should make guidelines for book donations.

#### 10.2. Publications

##### 10.2.1. Collection Policy Guidelines

The Guidelines have been published in four languages and the latest is a Spanish version.

##### 10.2.2. Newsletter

Report will be given in the next meeting due to time constraints.

### **11. Strategic Plan**

Due to time constraints this was postponed to next meeting.

### **12. Buenos Aires 2004**

The SC discussed about the contents of the Section's programme keeping in mind the following:

- The theme of the 2004 World Congress is "Libraries: Tools for Education and Development". President-Elect Kay Raseroka has adopted the theme, 'Life Long Literacy' for her 2003-2005 presidency, which will include the Congresses in Buenos Aires and Oslo. IFLA wants that all section programmes during this biennium should take President Raseroka's theme into account. Sections.
- The Congress in Buenos Aires will last five days, Monday – Friday. This shortened Congress, adopted in response to numerous member requests, will result in fewer programme slots. Therefore the Professional Committee has determined that each section will be entitled to no more than one 2-hour programme slot. '
- IFLA encourages sections to have speakers from Spanish/Portuguese speaking areas.

There were some proposals about the programme and individual papers e.g. on the strong reading and writing tradition in Colombia and legal deposits in Latin America.

The planning was postponed to the next SC meeting.

### **13. Oslo 2005**

The theme of 2005 World Library and Information Congress is "Libraries; a Voyage of Discovery."

Due to time constraints the planning was postponed to next meeting.

### **14. Any other business**

Section dinner was decided to be held on Sunday evening after the opening of the exhibition.

### **2. Adoption of the Agenda**

The agenda was approved as proposed.

### **3. Acquisition and Collection Development events at the Berlin Conference – feedback**

#### **3.1. Open programme**

There were 120 delegates. The programme was characterised as good. The approaches to gifts were different and it is very useful to know about that. Anna Popova said that the programme was useful for practice.

#### **3.2. Workshop**

There were 75 delegated attending the workshop. The quality of the workshop was good, it was well organised. Some members said that they were very impressed.

#### **3.3. IFLA Booth**

There were no delegates visiting the booth that would have been specially interested in the Section.

#### **4. Report of other meetings**

- 4.1. As Ann Okerson was not able to be present in the SC meeting it was proposed that she would give her report in the Newsletter.
- 4.2. There was an extra Coordinating Board meeting to elect new officers for Division V. The Chair is Edward Swanson and the secretary Hartmut Walravens.
- 4.3. President-elect Kay Raseroka's brainstorming session was held on Wednesday. The session discussed how to transfer the presidential theme (life-long literacy) to section level. The division chair will give a report on the session and it will be published in the newsletter.

#### **5. Membership issues**

The Chair noted that Trix Bakker and Sook Heyn Lee, Korea, Republic of were nominated as corresponding members / observers.

#### **6. Activities of the Standing Committee**

##### 6.1. Projects

##### 6.1.1. Acquisitions Bibliography

There was some general discussion, reminiscent of the previous year's meetings, about the usefulness of the bibliography. While Pentti has been maintaining the bibliography there has been little compliance with the agreement from last year's meeting that members should provide 5 important references and abstracts of them in English. It is a concern that the Bibliography is becoming increasingly out of date. While IFLA itself is unable to provide a database structure, which would greatly increase flexibility in creating and using the Bibliography, the Secretary will pursue the possibility of IFLA at least hosting such a database structure on IFLANET and will consult with Committee members on possible next steps.

##### 6.1.2. New Projects

Possibilities for new projects for the Section arose as a matter of discussion. A printed document on guidelines for donations of materials to libraries was suggested by the Chair, based in part on Kay Ann Cassell's well-received paper at the Open Session on "Gifts, Book Donations and Collection Development". Additional topics that might be included in such a document would be attention to the library's jurisdictional governing law(s) and policies on receipt, retention and disposal of gift materials. Kay will present a copy of her paper to Pentti who, in turn, will pursue publication options with the IFLA Secretariat.

The Standing Committee expressed interest in playing a continued role in helping to implement the recommendation number 5 from the IFLA Social Responsibility Discussion Group: "IFLA should work with commercial information providers to establish a standard price structure for publicly supported libraries based on ability to pay." [See Minutes from the First Meeting regarding the introduction of this topic.] It was agreed that some form of cross-divisional team was required, with participation from interested

sectors in IFLA, including vendors, and with members of the Social Responsibility Discussion Group. The Chair will contact the Publisher Relations Advisory Committee (PRAC) and will attempt to identify other interested players.

## 6.2. Publications

### 6.2.1 Section Brochure

The soon to be created online discussion list for the Standing Committee is the appropriate venue for discussion the proposed revision of the Section's brochure rather than addressing the issue during the business meeting.

### 6.2.2. Section Newsletter

Brief discussion addressed the fact that the Section's Newsletter normally is issued twice year, after the IFLA Governing Board meeting in November and prior to the Annual Conference. It was noted that IFLA still requires the issuance of a printed newsletter in addition to its online availability on IFLANET.

### 6.2.3. Other

Corrado Di Tilio agreed to share some possible ideas for publications via the online discussion list.

## **7. Strategic Plan, 2004-2005**

A very limited amount of time was available to engage in serious discussion of the Section's Strategic Plan for 2004-2005. The Plan is due by October 1, which means that much of the Standing Committee's attention to the task will have to be conducted online via the discussion list. It was noted that the Section is centrally concerned with issues of digital resources and that this should be indicated. It is imperative that the Plan takes cognizance of and is in sympathy with existing IFLA programmatic directives and initiatives.

## **8. Buenos Aires 2004**

Time constraints again limited the amount of discussion possible for this agenda item. The importance of relating the Section's program theme to the host region was acknowledged. The Chair suggested the theme of "Collections for Literacy & Development: Focus on Latin America". Discussion indicated that there are likely more possible speakers on aspects of the topic than time available to accommodate them all.

Sub-themes to be considered in the programming include: libraries and the development of society; digital approaches to education a population; how can collection development policies help in facing the educational divide; legal deposit considerations in Latin America; the role of indigenous peoples.

More specifically, Pascal Sanz will contact a colleague in Colombia about speaking on the culture of reading and the social role of libraries. Teresa Chapa, an observer at the meeting, volunteered to present on Internet resources in Latin America. Cooperative collection development in Mexico

was suggested as another topic. Possible poster sessions, to be sponsored by the Section, might include the Library of Congress's Cooperation Acquisitions Program for Latin America and/or the Association of Research Libraries' LATAMTOC (Latin American Table of Contents) cooperative project.

## **9. Oslo 2005**

A brief moment's discussion on programming for Oslo elicited quality controls in evaluating digital resources and electronic legal deposit as possible topics.

## **10. Any other business**

There was no other business.

## **Acquisition and Collection Development Section Strategic Plan 2004-2005**

### Background information

The Section on Acquisition and Collection Development focuses on methodological and topical themes pertaining to materials acquisition (purchase, exchange, gift, deposit), de-acquisition and weeding, techniques used for determining collection development policies, collection assessment and practices, materials pricing issues, and librarians' relations with publishers and vendors. Also of concern to the Section are the impact and application of technological developments that underlie many of the changes observed in departmental workflow, and partnering arrangements when acquiring materials (such as electronic data interchange, materials licensing agreements, and cooperative collection development). As access to materials becomes an increasingly viable alternative to ownership, the Section finds itself working more closely with the Sections on Serial Publications and Document Delivery and Interlibrary Loan, and the Publishers Relations Advisory Committee. In formulating its Goals the Section strives to be flexible and responsive to changing conditions in the professional environment. The Section is especially cognizant of the need to integrate its Goals with IFLA's thematic focus and professional priorities.

### Mission

The mission of the Section on Acquisition and Collection Development is to serve as a forum for the broader discussion and dissemination of information on evolving acquisition techniques and for promoting strategies for successful and effective collection development in libraries around the world.

### Goals

1. Continue to monitor and evaluate the impact of the electronic environment on acquisition functions, such as ordering and paying for materials

electronically, the creation and maintenance of machine-readable acquisition files, and collection evaluation and assessment techniques.

(*Professional priorities:* (f) Promoting resource sharing, (g) Preserving our cultural heritage, (h) Developing library professionals, (i) Promoting standards, guidelines and best practices)

(Continuing professional development)

Actions

1. Complete a revision of the Handbook on International Exchange of Publications
2. Consider the possibility of organising an event covering grey literature or, more specifically, electronic dissertations
3. Evaluate the possibility of conducting a survey on the impact of the electronic environment on acquisitions functions of libraries in Developing Countries
4. Consider a programme on quality control of electronic resources in Oslo 2005

2. Provide information on collection development activities, such as the formulation of collection development policies, policies on de-acquisition and weeding of collections, co-operative acquisition and exchange programmes

(*Professional priorities:* (a) Supporting the role of libraries in society, (d) Providing unrestricted access to information, (f) promoting resource sharing, (g) Preserving our cultural heritage, (i) Promoting standards, guidelines and best practices)

(Continuing professional development, Advocacy)

1. Continue to produce and coordinate entries for the updated Acquisition and Collection Development Bibliography, utilizing a flexible database structure that hopefully can be accommodated on IFLANET.
2. Consider future programme on collection development policies in an electronic environment.
3. Develop, for possible publication, a pamphlet on considerations governing the receipt and retention of gift materials in libraries, based, in part, on information presented at the Section's Open Programme in Berlin 2003.
4. Sponsor an independent workshop, to be convened in Finland in Spring 2004, on the theme: Preserving and Maintaining Availability of Print Material: the Role of Repository Libraries

5. Maintain a partnership role in promoting libraries' perspectives in the publisher and vendor communities in the areas of copyright, licensing, and the pricing of materials, with an emphasis on electronic documents.

**Minutes [Excerpts] of the Meeting of PRAC (Publisher Relations Advisory Committee to IFLA Secretary General and IFLA-IPA delegation)**

**I. Elsevier Science's Policy on Article Removal.**

This item was initially forwarded by Ann Okerson (Chair) because the Elsevier policy has been widely discussed on various e-mail lists. It is also an item of business potentially arising in the IFLA/IPA Steering Group. PRAC reviewed this statement in some detail and agreed there is much to admire about it. It represents one of the better policies in existence today. PRAC members very much liked the sense that article withdrawals would be rare, unlikely, and truly exceptional. The reasons given for retraction are substantive and appropriate. The distinctions between article withdrawal, removal, and replacement are clearly made. The group was pleased that Elsevier's official archives would continue to carry those rare items that might be deleted. The sense of an evolving policy is most appropriate.

**Improvements in were suggested as follows:**

- Provide clear definition of roles between author, editor, and publisher
- I.e., who does the retracting? Who does the removing? Publisher? Editor? Consultation?
- Provide advance notice to readers/customers that an article will be pulled.
- What will be the process if a journal changes ownership? I.e., how will this policy be implemented if an Elsevier journal is transferred to another owner?

**Suggestions *vis a vis* IFLA:**

- PRAC encourages IFLA and other library associations to review this policy statement, develop their own policies, and promulgate them.
- Consider how such a statement links to IFLA Freedom of Information principles.
- Recommend to IPA that a general policy be developed by publisher associations such as IPA, STM, AAP, PA, and others.

**II. IFLA's Draft Statement on Open Access**

The PRAC group commented that without significant work, there is and will be confusion between the way that IFLA uses the term "open access" and the way in which it is used in the broad STM community by researchers and academics. Open access is a concept or arena in which there has been great activity and publicity, which will only mount. (Reference was made to the Budapest Open Access declaration, signed by some 30,000 academics; and other conventions, newsletters, and numerous presentations and e-mail messages).

Some concern was expressed that this is "a typical IFLA document," high in principle although not accompanied by any action items. Therefore, what is it

intended to accomplish? The group wondered what the appended term "final draft" means. There was a question about process that led to the formulation of this draft: the document did not seem to have a lot of (visible) process attached to it, i.e., review within various IFLA committees, but rather it appeared rather suddenly from the "top down" on several diverse Internet public e-mail "lists" this past spring (not IFLANET).

One member noted that the contents of the document are very good; if one could swap out the term "open access" for a different one, it would be an excellent position statement. All were in agreement with this sensible comment.

### **III. Social Responsibilities Discussion Group -- Recommendations Statement**

Al Kagan, Chair of the SR discussion group, which had developed a series of recommendations for IFLA, has been approaching various IFLA standing committees in order to encourage action. There is no single (or handful of) committees that are logically responsible for most of the recommendations; so PRAC observed that the follow-through on these important items cannot easily be managed. The recommendations are appended below, and the ones of greatest interest to IFLA/IPA discussions and, therefore, to PRAC, are *italicized*. These are numbers 5, 8, and 9.

However, most of the PRAC discussions revolved around #5, i.e., *IFLA should work with commercial information providers to establish a standard price structure for publicly supported libraries based on ability to pay*. This item is of interest to all in the group, but particularly to our South African, Indian, and New Zealand members, for reasons related to weak currency and/or developing nations economy.

That is, the group admired the SR statement, even as it asked how IFLA could realistically implement very much of it, or at least in any coherent way. The question was posed: *Who/what/where in IFLA specifically focuses on needs and interests of developing nations? Or, more in a more specific example, "How could IFLA truly be of help to India as that nation's libraries attempt meet readers' information needs?"* Dr. Cholin re-stated his perception of the difficulties for developing countries: prices for publications are too high for such nations; increases are also too high; this leads to a constant cycle of review and cancellation. Even more, there are infrastructural difficulties related to facilities and now to digital information. These go to ability to buy equipment, to connect, to master the technology, and so on. Committee members were well informed about the various publishers' developing nations initiatives, documented at: <http://www.library.yale.edu/~license/develop.shtml> These are a good start but do not get us close enough where we need to be.

PRAC affirmed that the developing nations arena can be a very fruitful one for IFLA/IPA conversations; publishers and libraries should work together to take a long view of these issues, planning for a long-term beneficial relationship. For developing nations, prices should be increased gradually, at best, coupled

with loss leader pricing and other strategies. PRAC encourages this type of dialogue.

PRAC suggested that IFLA/IPA develop and issue a joint statement about content issues, infrastructural issues, and information literacy for developing nations.

PRAC further noted that IFLA responsibilities for developing nations are far too diffuse through too many committees and that further coherence should be sought. A committee or task force focused on Developing Nations Information Needs should be created.

### **Reports of projects**

New edition of the *Handbook on International Exchanges of Publications* should be ready this spring. It has been a long project starting in 2000. The compilers have changed as well as the list of contents. At the moment the handbook is being prepared in Finland by Ms Päivi Paloposki. The chair of the IFLA Acquisition and Collection Development Pentti Vattulainen is responsible for the project.

The new edition has three parts. The general part includes updated text of the previous edition and the international agreements, text on customs regulations, an article on the history of the international exchange of publications and an article on exchange of electronic publications.

Second part is a collection of articles based on the workshop held in Boston IFLA 2001. Third part is the directory on national exchange centres. It is collected by the Exchange Centre for Scientific Literature of Finland. Finally there is a modest bibliography.

### **Preserving and Maintaining Availability of Print Materials: the role of Repository Libraries – 2<sup>nd</sup> International Conference on Repository and Storage Libraries. Kuopio, Finland 13-16.5.2004**

Continuing the first International Repository and Storage library conference, held in Kuopio 1999, this conference studies matters connected with preservation and availability of print materials. Special focus is on economy of access to print materials. Also under discussion are centralised services, which have been developed to guarantee access to print material. Less-used materials are kept in centralised storage facilities, which allow local libraries to reduce costs for their collection space.

The speakers are leading international specialists from all over the world. The conference programme is built to allow much discussion and planning. The conference is meant for library policy planners, library directors, collection management officers and for those interested in advancing resource sharing.

The conference is organized under the auspices of IFLA and sponsored by it. Leading repositories of the world and some other institutions have participated in programme planning. These are National Repository Library of Finland; Center for Research Libraries, Chicago, USA, Le Centre technique du livre, Paris, France, CAVAL Archival and Research Material Centre, Melbourne, Australia; Bayerische Staatsbibliothek, Munich, Germany and IFLA Acquisition and Collection Development Section.
