It has been forty years since the IFLA Section on National and University Libraries decided to recommend the creation of a new IFLA committee, on Mechanization, in 1963. In the long way already covered, technologies matured, propagated, changed, diversified, changed again and again, and became more pervasive and complex. ## From the Chair (cont.)

## ITS Strategic Plan 2004-2005

## Mission

The Information Technology Section (ITS) serves to promote and advance the application of information technologies (IT) to library and information services in all societies, through activities related to standards, education and training, research, and the marketplace.

## Goals

**1** ITS will investigate, evaluate, and communicate knowledge about new technologies that have significant potential for library services, but which have not been widely adopted.

Professional priority: (I)Representing libraries in the technological marketplace.

#### Actions:

1 1 Investigate systems for authorisation and authentication to manage access to distributed and cross-sectoral resources and for supporting rights management. This will be the topic addressed in the ITS Programme in IFLA 2004;

1.2 Explore solutions and applications for library personalised services such as electronic reference services, electronic document delivery and recommender systems. These topics will be addressed by a new Project *Resource pages on Third Generation Library Information Systems*.

2 ITS will investigate, evaluate, and communicate knowledge about applicable IT for access to information resources, with special attention to needs regarding regions where telecommunication networks are of low capacity, or are not easily affordable. Professional priority: (d) Providing unrestricted access to information.

### Actions:

- 2.1 Continue the Project Information technology training needs assessment in developing countries (2000-).
- **3** ITS will identify and promote standards, guidelines and best practices for the management of information and IT resources and to improve efficiency and service level of library operations. This includes issues such as metadata and data structures, data manipulation techniques and long-term availability of electronic information. Professional priority: (i) Promoting standards, guidelines, and best practices.

### Actions:

3.1 Promote dissemination of best practices and experiences in defining IT policies to sustain library services infrastructure, notably in the aspects of IT security;

**4** ITS will promote data standards and protocols that will improve interoperability between systems and facilitate data exchange between libraries and between libraries and other sectors of information creation. Professional priority: (f) Promote resource sharing.

### Actions:

4.1 Monitor projects and recommend standards and best practices regarding the management of digital resources and repositories, from digital preservation issues to interoperability solutions for open access.

**5** ITS will encourage and support projects within the scope of the strategic plan by maintaining close contacts with other IFLA sections and Core Activities, as well as with other international associations and organizations focused on IT. Professional priority: (h) Developing library Professionals.

### Actions:

5.1 Liaise with other IFLA Sections to encourage ITS membership to provide feedback on new or revised IFLA standards and guidelines related with information management and with the management of IT supported information resources;

5.2 Liaise with other national and international associations, initiatives and standard bodies to enhance dissemination and cross fertilization of activities.

## Wireless Technologies for Library Services - RFID in Use

RFID was the topic of the ITS main session in Berlin. Mats Lindquist, Chair, introduced the theme, providing the past and present context for the application of this new technology in libraries. He reviewed briefly the advantages and drawbacks of barcodes and electromagnetic security systems, and argued that the potential of RFID should be analyzed by addressing a set of questions: price, reliability/robustness, longevity.

Vinod Chackra, from VTLS, presented the practical experience and components of the VTLS RFID Solution, which is integrated with the bibliographic system of the same maker. #### Alastair McArthur, from

Tagsys, explored five of the current most pervasive RFID myths. He pointed out myths about price and quality, interoperability, vendor qualification and memory size of the tags. Paper is online at http://www.ifla.org/IV/ifla69/pa pers/130e-McArthur.pdf.

Finnally, Chan Ping Wah explained a practical experience from the library point of view, based on the **RFID** implementation project at the National Library of MIC. Singapore.

## Digital preservation: current research, standards and best practices

This workshop was jointly organised by the IFLA ITS and the Preservation and Conservation Section. Maria Ines Cordeiro introduced and monitored the workshop. There were four papers in the programme, with ample time for discussion.

Seamus Ross (HATII & ERPANET, Glasgow, UK) spoke on the Challenges to digital preservation and building the digital library. While setting the scene and presenting the state of the art in digital preservation, Seamus drew attention to the features of digital objects, which, regardless of their digital format characteristics and the type of institution in which they are held (e.g., ALM institutions), should be

put under common preservation procedures. In this way, he stressed once again the concept of the convergence of ALM institutions.

Phyllis B. Spies (OCLC, USA) in her paper Attributes of a trusted digital repository presented the RLG-OCLC report Trusted Digital Repositories: attributes and responsibilities, May 2002.

Maggie Jones (Digital Preservation Coalition, UK) talked on co-ordination in the field of Digital Preservation Activities in the UK: Building the Infrastructure. The beginning of this coordination is traced back to 1995, culminating with the launching of the Digital Preservation Coalition in

February 2002. Maggie stressed that the Coalition's activities are of a highly collaborative nature in digital preservation and that the recognition is made of the issues cross both sectoral and geographic boundaries. The paper is available at: http://www.ifla.org/IV/ifla69/p apers/129e-Jones.pdf.

David Seaman (Digital Library Federation, USA) in his presentation co-authored with Stephen L. Abrams (Harvard University, USA) presented a different aspect of the issues concerned with the preservation of digital resources. The focus was on the digital format, i.e., meeting the needs for a sustainable, global registry of digital representation formats

## Scholarly portals workshop

The IT Section, together with the University Libraries Section, organized this workshop. Portals are a hot topic in many research libraries these days. The workshop gave us a very useful overview, looking at the issue from many angles.

After an introduction by Larry Woods (University of Iowa), Mary Jackson told us about the Scholars Portal Project developed by the ARL (USA). The project aims 'to develop a suite of scholarly productivity tools and services designed to facilitate an academic user's wish to integrate, manipulate, exploit and explore the academic content universe'. That is quite a mouthful; and that is why portal projects are complicated. They decided to use Fretwell Downing software and the first pilot site, at the University of Arizona, went live in January 2003. Their main problems at the moment are in adding all the content required by the users

The AARLIN project, in Australia, chose to use the *ExLibris* software. They stressed that 'federated' searching across multiple resources should work just as well as searching in the individual sources. This is a major problem: often some search quality is lost in the federated search process. They too have a problem in integrating all the sources required: they selected 2500 content sources of which, at the moment, only 200 have been configured for use.

Three vendors discussed portal features: *Endeavour*, *Fretwell Downing* and *Ex-Libris*. These are only three out of some 25 suppliers currently working in this field. No doubt they all struggle with the same problems.

*Endeavour,* with *EnCompass,* stressed that the digital library should have many doors: we want our users to find and use the information, so we give them as many ways to that end as we can think of. A portal is one of these ways. Maintaining access to diverse sources, with superior results, is a main problem in portals. *XML gateways* seem promising.

All three providers recognize the need for collaboration between libraries and consortia using the systems and vendors to fill a knowledge base with data on how to access various sources for use in portals. And to keep this up to date. *Fretwell Downing* expanded on their *Knowledge Base*, and on ways to distribute the information.

#### Ex-Libris (Metalib)

discussed issues surrounding end user authentication. This is needed to determine access rights but also to allow profiling and personalization. Different sources require different types of authentication (IP address, username, password etc). We all hope that the *Shibboleth: Internet 2* /*MACE* project for cross-domain authentication and authorization will provide the solution:

Finally, *Cornell University*, *University of Arizona* and *Charles University* (Prague) told us about their experiences with portals.

**University of Arizona** stressed that we librarians should press for agreed standards to be used by information providers.

**Cornell University** promised us usability studies - we look forward to reading them! They force users to choose a maximum of 8 databases to search during any one broadcast search: this optimizes search time & results. This seems a very sensible limitation.

**Charles University** (Prague) seems to be struggling with the same problems we all encounter. They confirmed the slogan that **Larry** used to end his introduction: 'Portals in any form are collaborative tools'.

## IFLA Satellite Meeting – Information Technology & DCMI

Göttingen, 11-12 August 2003

This Meeting was jointly organised by the IFLA IT Section, the Dublin Core Metadata Initiative (DCMI) and the Göttingen State and Gartner) and metadata University Library (SUB), the registries (Harry Wagner & organization hosting the event.

Conveying an international panel of speakers, the programme focused on various aspects of Dublin Core metadata developments (Stuart Weibel), OAI in Europe and Germany (Uwe Müller, Diann Rusch-Feja), issues

of metadata for long-term preservation of digital assets (Heike Neuroth, Ute Schwens), METS (Richard Thomas Fischer).

The Meeting included a topical approach to strategies and experiences in the constitution and preservation of digital assets, with two presentations of projects in the domain of Mathematics (Galina Evstigneeva, Bernd Wegner).

The meeting gathered about 50 participants, from six countries, and was an excellent opportunity for updating knowledge about current initiatives related to metadata and to explore future directions and trends in collaborative efforts. In this respect, a special note should be made about the announcement of the DCMI's National Affiliate Program (http://dublincore.org/about/af filiates/). This is a new approach to advance the maintenance, governance

and management of DCMI through the participation of regional constituents. Stuart Weibel (OCLC) and Elmar Mittler (SUB) closed the event with a discussion about these new perspectives in DCMI governance.

## Authentication & authorization for cross-domain e-library services

A&A systems is the topic selected for the ITS programme in IFLA 2004

#### Aim and scope:

The growth of disparate online publishing, both at institutional and commercial levels, has been raising the need for e-resource management solutions that can integrate access services and support control over their usage. Authentication and authorization issues are a fundamental part of the solution. Strategies and infrastructures for efficient management of access to distributed resources in a crossorganizational environment are, therefore, of utmost importance for library managers, e-content providers and users.

In the last few years many different organizations have been addressing such concerns and producing experimental research, standards, solutions and actual services. The IFLA ITS programme for 2004 aims to promote awareness and discussion about current developments and trends in authentication and authorization related to library services. Envisaged coverage includes: requirements for access management to electronic resources, different approaches and experiences, and available technical options.

#### **Reference to IFLA's Professional Priorities**

The focus of the IFLA ITS 2004 Programme connects to several of the current IFLA's Professional Priorities, notably: "Balancing the

intellectual property rights of authors with the needs of users", "Promoting resource sharing and standards", "Promoting guidelines, and best practices" and "Representing libraries in the technological marketplace". Furthermore, because authentication and authorization solutions are a necessary component of the technical infrastructure that allows library users to access distributed information resources in more flexible and transparent ways, it also links to the IFLA Presidential Theme 2003-2005 "Libraries for Lifelong Literacy".

#### Target audience:

Library IT and network managers, digital library and electronic collections managers, managers of library consortia, and publishers and providers of online publications.

**ISBD (G)** General International Standard Bibliographic Description. 2003 Revision. The main objective of this revision of ISBD (G) is to ensure conformity with the FRBR's data requirements for the "basic level national bibliographic record". Changes in terminology were also introduced, in accordance with the conceptual model of FRBR.

# CONFERENCE REPORTS

## ECDL 2003

Attended by 360 participants from 36 countries, the 7th edition of *ECDL* -*European Conference on Research an Advanced Technology for Digital Libraries*, was held in Trondheim, Norway, from August 17-22. http://www.ecdl2003.org/

The full three days of the main conference were added with more three days of tutorials (9 )and workshops (5). These, which are not included in the proceedings published by Springer, covered a wide range of topics and at least for the workshops most of the material is now available on the Web:

The other are the three **panel sessions**, all of them lively debates on hot and controversial topics:

- The future of academic publishing (Panel: Leo M. F Waaijers, Wageningen University Library; David C Prosser, SPARC Europe and Michael Mabe, Elsevier Science) in which the classic subscription model versus the upcoming Open Access Model were confronted;

- Digital? Libraries? (Panel: Stephen Gradman, Univ. Hamburg, Jela Steinerova, Bratislava Univ,; Vittore Casarosa, CNR Pisa and Dan Atkins, Univ. Michigan) discussing the terminology, scope and meanings of the "digital library" concept(s).

- **Digital Preservation** (panel: Michael Day, UKOLN; Steve Knight, Nat. Library of New Zealand and Catherine Owen, Performing Arts Data Service) which addressed the needs and strategies for digital preservation metadata.

## DC 2003

From September 28 to October 2, 2003, University of Washington hosted the 2003 Dublin Core Conference. Supporting Communities Discourse and Practice was the theme of DC 2003. the 11th international Dublin Core Workshop and the third annual Conference in a series on metadata applications held by Dublin Core Metadata Initiatives. More than 300 attendees including digital library researchers, Internet networking specialists, content specialists, educators and librarians from 20 countries or regions participated in the conference. In a total of nearly forty sessions in four days, twenty-three papers and twelve short papers/posters were presented. Stuart Weibel, the former DCMI director, summed up the advancements of the last year, notably the fact that Dublin Core had become globally adopted by ISO, CEN, NISO and many others as international and national standards. A wide range of topics was highlighted in the conference, such as the development and maintenance of metadata schema; the metadata creation, including models, methods, tools and quality control; metadata uses in the areas of access, users, and specific needs; metadata implementations from both systemsoriented and collaborative approaches; domain specific metadata; interoperability issues, and the metadata evaluation, aggregation, use, and reuse, etc..
