At the IFLA World Library and Information Congress in Kwazulu Natal, the IFLA Honour was presented: "The person nominated for honorary fellowship this year has made a major contribution, over a long period of time, in her own country, in her region, and worldwide. She has been a driving force in promoting the entry of her continent,

Africa, into the Information Society.

She has highlighted the value of indigenous knowledge and of its appropriate utilisation, and has promoted recognition of the importance of orality in indigenous communities.

She is a respected leader in Africa and in the developing world generally. She has been a strong leader and a dignified and respected spokesperson for the library community and for IFLA in International forums such as the World Summit on the Information Society. In 2003 she became IFLA's first African President. Today, in the province of her birth, we honour --- Kay Raseroka.

## Saturday 18th August 2007 Durban, South Africa

### 1. Opening.

The Chair, Ragnar Audunson, welcomed all to the first Standing Committee meeting of Library Theory and Research Section at the IFLA Durban conference. The Agenda as set in the LTR Newsletter July 2007 was adopted.

2. The Minutes of the SC meetings in Seoul on the 20th and 25th of August 2007 were accepted. Ragnar commented on the importance of the Journals section joining with LTR.

3. The Treasurer reported that there have been no expenses as yet during the year. However, it is anticipated that a new leaflet will incur printing costs before the end of 2007. The payment to Bob Usherwood has been sorted.

4. Ragnar Audunson was elected to a second term as Chair of the Section and Marydee Ojala was elected to a second term as Secretary/Treasurer of the Section.

### 5. IFLA business in Durban:

Ragnar reported on the Coordinating Board VII meeting held on the 17th of August in Durban. The Information Literacy SC is particularly impressive, particularly in pursuing outside funding. A hearing on the proposed new professional structure will be held on Sunday, the 19th of August. A new officers training session will be held on Monday, the 20th of August.

### 6. LTR session in Durban:

Ragnar presented a Certificate of Appreciation to Kerry Smith for her work in organizing the session. We have accepted five papers, one of which will be delivered in French. The countries represented by the speakers are Tunisia, Kenya, South Africa, Botswana, and Nigeria.

### 7. Project status

Bob Usherwood's project on the *Political perceptions of public libraries* is completed and is in publication stage as an IFLA professional report.

Ragnar's project on *IFLA's role in diffusing professional norms* is ongoing. Data collection is almost done. Papers reflecting research in specific countries was presented both at the IFLA conference in Oslo and in Seoul. A new survey was distributed this spring, based on the participant list from Seoul, corrected for an oversupply of names from Scandinavia and South Korea. The response from about 200 people has produced some interesting preliminary results. More participation is needed from some geographic regions, particularly Africa. Ragnar expects to finish the project by the end of 2007.

### 8. Programme planning for 2008 in Quebec City and 2009 in Milan

The main theme of the conference is *Libraries without borders: navigating towards global understanding*.

We should look into the possibilities of a satellite event in 2009, to be held in Italy, near Milan. Our topic for 2008 will be *Libraries as places*. This would start as a session in Quebec City, then move to Milan as a satellite event.

Our topic for 2009 will be *Open access*.

We will issue a call for papers for Quebec City.

We will investigate the possibility of a student competition focused on a literature review of open access for Milan.

### 9. IFLA's professional structure:

The proposal is an attempt to reduce bureaucracy within the association. It is proposed that there be four broad divisions, organized by library types; materials, function & services; support of the profession (which is where LTR would be placed); and geographical regions.

### 10. Other business

Ann Curry asked for suggestions regarding a project to establish a research agenda for a country.

11. Chair Ragnar Audunson closed the meeting at 16.35 hrs.

1. Opening: Ragnar welcomed all to the second meeting of the Standing Committee meeting. He congratulated Marian Koren, Information Officer, for her editorial work on the SC newsletter, which resulted in winning the runner-up prize for most improved newsletter.

## 2. IFLA business in Durban

Ragnar reported that the proposed restructuring has been under review throughout the conference. The major change in the proposal is that the number of divisions has been increased from four to five. Also, the minimum number of members for standing committees remains under review and is fluctuating.

## 3. Review of LTR sessions in Durban

The session was very successful, with about 80 attendees. The papers were of high quality and gave a good picture of challenges faced by African researchers, both regionally and nationally. Four of the five papers were delivered. The speaker from Nigeria was unable to attend. If funding is a problem for speakers from developing countries, they should be put in touch with ALP. Two of the papers have already been published in the *South African Journal of Libraries and Information Science*. LTR will propose Gdoura's paper on the history of research in francophone Africa to Division VII for publication in the IFLA journal.

## 4. Future conferences

Discussion continued on future conference session topics.

The Quebec City session on libraries as places should include public, academic, special, and virtual libraries. Papers should concentrate on the theoretical aspects of the topic. Ragnar has drafted a call for speakers. Eileen Breen volunteered to help distribute the call.

Biddy Fisher has a colleague who could coordinate logistics for Quebec City speakers.

Marketing and Management has expressed interest in cooperating on sessions in Quebec City. We could share with them, if they include the words "theory" or "research" in their title, which currently is *Managing in a changing environment*, but do not want to give up our session time.

The satellite event in Milan will move the topic from the theoretical to the empirical. Ragnar will investigate partnering with another SC. LTR will submit a request to hold a satellite event on its own in case the partnering does not transpire.

The Milan session on open access will be coordinated by Helen Partridge. Only one student submission from each university will be considered. We will investigate if there is sufficient technology to support distance presentations, in case a winning student would be unable to travel to Italy. The student could present the paper using some type of streaming media technology.

Another topic of interest for future conferences revolves around the research agendas of governments being an obstacle to research. Perhaps in Brisbane we could look at public policy regarding research agendas. Where are the research gaps where collaboration would be beneficial? What is the agenda for practitioners in regards to research. This theme could be related to the section of Management of Library Associations.

## 5. Strategic plan

LTR will revise its strategic plan to reflect its changing topic priorities, including library as place, stimulating research, open access to information, research agendas.

The plan will set out LTR's main priorities until 2010. The research agenda will hopefully result in a book on research agendas, giving the "state of play" by region. Kerry Smith is interested in editing this book. Ann Curry, Biddy Fisher, and Helen Partridge will work with Kerry on the project.

Eileen Breen will review a draft version of the strategic plan from the perspective of the former Journals section.

## 6. Annual report

The annual report will be dated from conference to conference (August to August), but is to be filed mid-January.

It will summarize information from the minutes and the newsletter.

## 7. Leaflet

An updated leaflet is necessary to reflect changes in LTR priorities and strategic plan. Translations by SC members will be encouraged.

The goal of the leaflet is to encourage new members to the section.

It can be put on the Emerald website since Emerald is a corporate sponsor. It can be mentioned in Libris with a link to the LTR website.

## 8. Other business

Terry Weech distributed the BOBCATTS leaflet for its 16th Symposium.

9. Adjournment. The meeting adjourned at 15.50 hrs.

## Library Theory and Research STRATEGIC PLAN 2007-2008

### Mission

**The IFLA Section on Library Theory & Research exists to:**

- provide a research-based framework to IFLA's professional priorities through a program promoting theoretical and empirical library and information science research and analysis;
  - provide and encourage international networking opportunities for library professionals engaged in library and information science research.
- Professional priorities:** Supporting the role of libraries in society; Developing library professionals; Promoting standards, guidelines and best practices.

### Goals

**1. Encourage exchange between practice-based and theoretical research in LIS.**

#### Actions

1.1 Encourage theoretically as well as empirically based papers at IFLA and IFLA sponsored conferences. In the coming period the section will focus upon libraries as place and space (Quebec and Milan), open access to research (Milan) and research agendas for LIS-research (Brisbane).

1.1.1. Quebec 2008

Theme: "**Libraries without borders: Navigating towards global understanding**"

- A session on Theoretical approaches to research on **Libraries as space and place**  
Libraries as space and place have become an important research topic within library and information science. How can libraries develop into places promoting community, knowledge sharing, citizenship, confidence and trust? Such research questions are relevant for public libraries as well as for academic, government and special libraries, and they are relevant for digital libraries as well as physical libraries. At its session in Quebec, the IFLA section on Library Theory and Research will focus upon research on libraries as space and place. In particular, we want to examine theoretical approaches when doing research on this issue, e.g. theories on the public sphere, concepts and approaches related to social capital, approaches from knowledge management such as communities of practice, the concept of The Third Place, etc.  
Papers discussing the fruitfulness of different theoretical approaches when researching this topic in general or when doing research on libraries as space

and place in particular contexts, e.g. an academic context or a local community context, are welcomed.

- Contribute to the session **Managing libraries in a changing environment** together with the section on Marketing and Management and Statistics and Evaluation.
- Completing the research projects on IFLA's role in promoting change and diffusing professional norms.

1.1.2. Milan 2009

Theme: "**Libraries create futures: building on cultural heritage**"

- Libraries as space and place: The topic libraries as space and place will be continued with a satellite conference focusing upon empirical research and practical examples.
- Open access to research is a highly salient and much debated topic. LTR invites graduate students to submit research papers on this topic. The best papers will be presented at a session at the Milan conference in 2009.

1.1.3. Brisbane 2010:

- A session on Research agendas for Library and information Science.
- LTR to communicate with the IFLA Management of Library Associations Section and library schools.

1.2.1 To commence knowledge exchange amongst LTR members;

1.2.2 Evaluating research projects for their relevance to IFLA's professional priorities and LTR's goals.

**2. Assisting in the development of expertise and knowledge in useful research methods**

#### Actions

- Evaluate conference papers for possible inclusion in IFLA and other journals.

## News from Division VII, Professional Committee and Governing Board



The IFLA Governing Board (GB) met in cold and rainy The Hague, Netherlands in December 2007. The main points of discussion were as follows:

### Revision of IFLA Statutes and structure

The revision of IFLA Statutes has the aim of implementing the changes resulting from the consultation process conducted by the Professional Committee during 2006 and 2007, incorporating other changes approved by the Governing Board. This revision offers an option for the recognition of personal affiliates as "Personal Members". The revised Statutes are to be approved by the IFLA Council in Quebec. A subgroup has been nominated with the authority of suggestions and additional comments with deadline in March 2008. The Professional Committee has the task of coordinating the transition in the new Sections and Divisions structure. The elections of the new IFLA structure are before Milan and running soon after the conference. In Quebec an information meeting will be held at the start of the Conference.

### Financial matters and IFLANET

The budget situation is good, especially for input from Conferences. The Bill & Melinda Gates Grant will be used a.o. for a new IT system and IFLANET, incl. staff. IFLA will consult section members on the transition to the new software. IFLA benefits of ILL Vouchers made electronically and arrangement is running well with British Library and OCLC. Membership has increased but efforts will be made with the help of IFLANET to improve communication, and include responsibility of Regional offices to do more recruitment.

### 2008 Multilingual year and IFLA languages

2008 is the year of Multilingualism and the Conference in Quebec will promote multilingual aspects. All Sections should discuss Multilingualism in the meetings, with constant reminding of it. It was suggested to have a guest speaker on the topic, and a plenary session; and to have a special issue of the IFLA Journal with a Call for Papers on Multilingualism.

The connection between literacy and language was stressed.

Conference translations of IFLA express add importance to the English original. The first community to start to do translations has been the French community, with approval from IFLA but with all the costs paid by the language community. Now, a new agreement gives to the languages communities the responsibility of mobility and accommodation costs of translators, including coordination (dealing with time schedule, getting papers in time etc.). IFLA will support the translation with the availability of rooms, equipment, editing layout and all software infrastructure needed, including printing costs.

### Core activities

Core activities are all looking for better coordination with IFLA structure and sections, and with partners. *Preservation and Conservation (PAC)* prioritises training; trainers are needed: a database of trainers in different languages will be set up. Training material needs to be shared, including books, films for e-learning, practical exercises for the disaster planning. In Milan 2009, a Conference on safeguarding monuments and heritage at risk is planned. *Action for development through Libraries Programme (ALP)*: The cooperation with the Regional Offices, and Division continues. The Balkan countries will also be included in the Developing Countries Group, and be included in ALP activities. *Alliance for Bibliographic Standards ICABS*: Major changes are taking place in the internetbased world and the access to digital sources. IFLA works for leadership in the field of bibliographic standards also regarding digital resources. Transdivisional activities from Library services and bibliographic control need a first step: a Liaison Group for Bibliographic control and ICABS will prepare a proposal to be discussed in GB meeting in April 2008.

Section "Recherche en bibliothéconomie et en sciences de l'information"

THEME: Approches théoriques sur la recherche relative aux bibliothèques en tant que lieu et espace  
Le lieu et l'espace que représentent les bibliothèques sont devenus des thèmes de recherche importants pour la bibliothéconomie et les sciences de l'information. Comment, en effet, les bibliothèques se développent-elles pour devenir des espaces de promotion des communautés, de partage des connaissances, de citoyenneté, de confiance et de sécurité ? De telles questions sont pertinentes pour la recherche relative à des bibliothèques publiques mais aussi des bibliothèques académiques, des centres d'information spécialisés et elles portent à la fois sur les bibliothèques physiques et les bibliothèques numériques.

C'est le thème choisi par la section "Recherche en bibliothéconomie et en sciences de l'information" de l'IFLA pour sa session à Québec. Elle souhaite, en particulier, examiner les approches théoriques que l'on aborde lorsqu'on étudie ce thème, soit, à titre d'exemple, les théories sur la sphère du public, les concepts et les approches liées au capital social, les approches sur la gestion du savoir en tant que communauté de pratiques, le concept de "troisième endroit" etc. Elle retiendra tout particulièrement les communications relatives à l'utilité des diverses approches théoriques quand on étudie cette question en général ou quand on fait de la recherche sur les bibliothèques en tant que lieu ou espace dans des contextes particuliers, dans un contexte académique ou dans celui d'une communauté locale.

## Aims and scope

*All types of libraries – academic, public, school, special, and governmental – must respond quickly to many demands in a rapidly changing world. Some of these changes come from developing technologies, while others come from new and changing legal requirements, or from experiments in changing organizational structure. All these demands have a significant impact upon the management of libraries. In order to research and assess the impact of various management challenges, libraries must turn to benchmarks, standards, and guidelines, while working within the theory and principles of librarianship and governing laws.*

## Relevant topics for the Program:

- Adjustment of general management principles to a changing library environment
- New strategies for an effective organizational structure to advance the library's mission
- Impact of a changing legal environment that affects the provision of services and resources of Libraries
- Use of new technologies to advance the effectiveness and efficiency of Libraries.
