There was a historic moment last year in Boston when this section emerged from being a Discussion Group. The establishment of this Section was preceded by a four-year period of planning and strategic work with enthusiastic people, and we would like to thank all these people for their encouragement and support. A short history of the Section is on page 2.

The Standing Committee is provisional until regular nominations take place in 2003. Thirteen people were elected at the Boston conference, including the interim Chair, Secretary/Financial Officer and Information Coordinator. In March, six members were approved, making a total of 19, plus one

corresponding member. Since the geographic balance is good and since there is a variety of library types represented, we trust that many aspects of this field of library work will be considered.

This is the first issue of our Newsletter and it includes the minutes from the two SC meetings held in Boston, our Mission and Strategic Plan, a report on our Digital Reference Guidelines project, and highlights of our programs for Glasgow. This is a hot topic and we expect many participants, so we advise you to register quickly for this workshop.

## IFLA Discussion Group on Reference Work: a 4-year perspective

Reference service is a fundamental pillar of our libraries and has become even more important with the information explosion on the Internet. While we often hear "You can find anything on the Net," as librarians we know that this is not true. We know there are lots of pitfalls and the quality of information on the Internet is not always good.

It is extremely important for these matters to be discussed and considered on an international level, and IFLA is the appropriate forum.

Until 1997 there was no forum within IFLA specifically addressing Reference Work. At the Copenhagen conference, I took the initiative of starting a Discussion Group as an affiliate of the Section of Document Delivery and Interlending. The number of participants has increased every year, from 40 for the first meeting to 150 in Jerusalem.

The first official meeting was in **Amsterdam** (1998). The topic was *The Organization of Reference Services*. In order to find out if organizational structure for reference services varied

with library type, a small study was organized. The following four library types were identified: National Libraries, University and Research Libraries, Public Libraries and Special Libraries. For each, a coordinator was asked to conduct and report on a survey based on three questions:

1. Where in the organization is the reference department found?
2. Which services are offered, and are there different levels?
3. What are the positive and negative effects?

The substance of the discussion was as follows. It is not the organization itself that is important, but rather the needs of the users and what they expect from reference librarians. We can expect information technology to change our organizations, but don't yet know how we can best serve the

users, whether physical or virtual service. Which services are we going to provide in the future? How do we adapt our library organization to meet with future needs?

The second official meeting took place in **Bangkok** (1999). Our Discussion Group theme was *The New Definition of Reference Work in a Changing Reference Culture*. More than 100 people from different parts of the world attended the meeting. Two of the eight papers referred to surveys based on the questionnaire from previous year. Their conclusions highlighted the changing relationship between reference librarians and users. One of the challenging facts -- if reference librarians cannot provide the high quality service users need and expect, users will try to obtain their answers from other reference service providers.

Additional topics of discussion in Bangkok included roving reference librarians and their use of wireless

communication, the "virtual reference interview" or how to make the computerized reference service more human, and declining reference desk statistics.

The **Jerusalem** (2000) meeting, *A Space Odyssey: Building Bridges between Virtual and Physical Reference Services*, attracted more than 150 reference librarians. Five discussion papers provided a basis for discussion. The topics included new services, such as the Collaborative Digital Reference Services of the Library of Congress, and reference services within special collections, such as European Document Information. Additional discussion focused on real-time digital service and changing models for the physical environment for offering reference (such as roving reference librarians instead of a traditional reference desk), the changing role of librarians, and the importance of attracting young professionals to reference service.

## Minutes: Interim Standing Committee Meeting I August 18, 2001

### Introductions & attendance:

Members of the Standing Committee and Observers introduced themselves. All members of the SC present except for apologies received from Diane Kresh. A total of 37 individuals attended the SC meetings.

**Announcements:** The SC can have up to 20 members, but the SC needs more geographic balance. Various

meetings at the IFLA conference were announced.

**Annsofie's Report:** Some history of the Discussion Group's transformation to a SC was provided. (See "IFLA Discussion Group on Reference Work: a 4-year perspective" elsewhere in the newsletter.) In March the IFLA PB converted the Discussion Group into a Standing Committee and an Interim Standing Committee was established. The Coordinating Board of Division 5 to which the SC belongs approved candidates for the interim with the idea that more individuals could be added during and after the Boston conference.

**Election of Interim SC officers for 2001-2003:** Annsofie Oscarsson was elected as chair, Marty Kesselman was elected Secretary/Treasurer, and Cathy Wojewodzki as Information Coordinator.

**Financial Report:** No funds have been given to the SC but 720NLG are available for this year.

**Strategic Plan for 2002/2003:** The Strategic Plan replaces the Medium Term Program of the past. It consists of 3 parts -- mission, priorities and action plan and should be linked to the IFLA List of Professional Priorities that we reviewed at the meeting. It was decided that Annsofie, Marty and Cathy meet between the two SCs and develop a draft plan. Some brainstorming produced the following list of ideas:

- Develop a listserv for the SC.
- Develop a website that keeps track of late breaking news regarding reference -- "RefWatch."
- Raise awareness and consciousness about reference and marketing reference services effectively. How can we make ourselves more visible? It was noted that we are the "hidden secret" in the library.

- What is professional work in reference work these days?
- State of the art of what reference work is like in various parts of the world.
- Investigate what guidelines exist for reference service.
- Problem of vocabulary -- in some languages there is no word for reference service, sometimes vocabulary can be limiting -- we are the only profession that has the name of the place we work as part of our title.
- Knowing our competition -- survey and evaluation of the numerous web-based services providing reference-like services.
- Need to market the new SC -- develop a brochure.

### Boston Conference Matters:

Program is Monday. It was noted that IFLA has not included PowerPoint presentations on IFLANET and that we should add these presentations to the Reference Work SC website. Cathy as information coordinator and responsible for the SC website will look into this. [It was later learned that IFLANET has chosen not to mount PowerPoint presentation files.] Also noted were several poster sessions related to reference services and a workshop by the Social Sciences SC covering electronic reference service at MIT.

**Glasgow Conference:** We agreed on a workshop entitled, "How to Start a Virtual Reference Service in Your Library." Anne Lipow will coordinate the workshop and locate an off-conference site. Several ideas were expressed for topics including those mentioned already during the brainstorming on the strategic plan. Additional ideas: (1) Making Ourselves Visible, (2) Who needs our services and how do we get ourselves out there? and (3) Knowing the Competition.

# Interim Standing Committee Meeting II

**Boston Open Session:** There was an overflow crowd of over 300 persons, which demonstrates great interest in the SC. Need for simultaneous interpretation was noted.

**Workshop for Glasgow:** Anne will coordinate and plan for a site in Scotland for the workshop. Topic is "How to Start a Virtual Reference Service in Your Library."

**Open Session for Glasgow:** Topic decided on is Globalization of Reference Services with the following possible themes:

- Cultural differences and reference.
- Reaching out to multicultural populations
- New roles for reference librarians
- Cooperation / Collaboration of reference services.

Bodil Wohner, Andrea Delumeau, and Josje Calff will be responsible for

developing the open session.

**SC Project Submitted:** The SC submitted a request for a small project to the CB to identify guidelines that exist for electronic reference services. Vera Fullerton will direct the project.

**Brainstorming for Berlin:** One additional topic involved Libraries and the role of reference librarians in helping to build democracy.

## Examining the Current State of Digital Reference Standards

During the IFLA 2001 Conference in Boston, the Reference Section submitted a project proposal to identify and monitor efforts toward the creation of digital reference standards.

Strong interest in developing standards and guidelines for digital reference services exists among librarians as evidenced by articles in the library literature, discussions on list servs, and conference topics. At this stage however, many librarians are still engaged in debate regarding the merits of the service, when to offer it, how to staff it, software selection, etc.

Most libraries offering a virtual reference service are at the pilot or early post-pilot stage. If digital reference standards are in place, they tend to be in the form of internal documents, informal in nature, and closely reflect those used for general reference services and e-mail reference. In most cases, libraries offering a digital reference service offer information regarding privacy guidelines and service restrictions.

The wealth of literature regarding standards of traditional reference and e-mail reference services will serve as a useful resource during the development of digital reference standards. However, the unique nature of digital reference introduces new realm of issues and challenges. This need for standards becomes even more important as consortium-wide

digital reference services continue to evolve.

The Virtual Reference Desk (VRD), a project dedicated to the advancement of digital reference and sponsored by the U.S. Department of Education, has taken the lead in working towards the development of standards. Large consortial-based virtual reference services, such as CDRS, have looked towards VRD for the development of standards. VRD's current version of digital standards, entitled

"Facets of Quality" is available at <http://www.vrd.org/facets-10-00.shtml>. The National Information Standards Organization (NISO) is also exploring the issues and opportunities associated with the development of digital reference standards.
