# 1. Presentation of Committee and corresponding members

## 3. IFLA HQ and Division business (Mel/Ruth)

Mel and Ruth reported from the Coordinating Board that was mostly dominated by the forthcoming special hearing on the Professional Committee's suggestions for change. Nancy

Bolt, chair of The Coordinating Board said that the Section review committee to which she had been appointed had never met. She advised to put our questions in writing and told said there would be no decision until the December Professional Committee meeting.

## 4. Professional Committee-meeting Sunday on future of sections.

The item was discussed and arguments were brought forward. The suggestion of a minimum membership of sections of 50 was met with especially great dissatisfaction. The question was raised, whether a personal membership counts. Later response from IFLA-headquarter assures that it does, so everybody is strongly urged to persuade colleagues not at least from smaller institutions to join our section as personal members. Everybody was urged to speak up in the special hearing meeting. After lunch some of the participants stayed and put together a paper with questions and comments for the special hearing.

## **5.** Financial report (Janice)

Janice reported expenditure for the year to date amounted to £117.27 for reproduction and posting of newsletters 7 and 8. This included £50.22 which had been carried over from 2005. No invoices had been received to cover the membership mailing carried out by Mel. Janice was still uncertain about the transfer of accounts to HQ and how this would impact on her ability to complete annual reports, highlighting concerns over exchange rate and payment details.

## 6. Open Session status report (Mel)

Mel reported everything is ready and all speakers are expected to participate.

## 7. Study Tour and workshop status report (Guiwon Lee)

Thanks to Guiwon Lee this task has been so easy for our committee this year, as she has done a very well planned study tour, and moreover has organised a workshop on Korean genealogy to take place at the National Library. We are very grateful for her efforts.

#### 8. Membership drive (Mel)

Mel has written a letter to the members of the section expressing our gratitude of their support. A survey of our achievement since the first beginning in 1999 was included with the letter. Mel has sent recruitment packets (letter, leaflet and fact sheet) as follows:

There was some confusion as to the exact membership of the section, as Ruth had got an inaccurate list from IFLA. Ruth will get the exact list after the conference and have it sent to the committee members.

Raymond Wright suggested that a membership-drive letter be sent to public libraries with genealogical and local historical collections. He is willing to send letters to such institutions in USA. Mel will look at the regional level. Janice is willing to look at public libraries in UK. Jürgen will translate the membership-drive letter to German. Ruth will translate it into Danish. Ruth will cope with Denmark, Norway and Sweden. Hopefully others will do the same in their countries, which for most of us will be easier than covering all of USA.

Recruitment letters will be sent out by the end of October. Ray will be in charge.
