3. Approval of Agenda.

4. Minutes of the 28th Meeting, National Library of Singapore/Matters Arising

- 4.3 Minutes 5b. African Newspapers.
- 4.3.1 Christiane Baryla reported that Bookkeeper will be in contact with the National Library of South Africa.
- 4.3.2 **Ed King** is to ask again Douwe Drijfhout for the list of newspapers in sub-Saharan countries that are priority for microfilming. Also for an update on the activities of the National Library of South Africa in this area.
- 4.4 Minutes 5f, **Ed King** and **Pär Nilsson** to raise the matter of RDA with IFLA Cataloguing Section. [Later note: Barbara Tillett welcomed the cooperation of the Newspaper Section.]
- 4.5 Minutes 6f, Singapore Press Holdings may consider the matter of sponsoring a delegate to IFLA Milan. This to be followed up with Idris Rashid. Action: **Hartmut Walravens and Ed King.**

5. Newspapers Strategic Plan for 2008-2009.

The plan was looked at via an internet link to IFLANET. No further comments were made. Further detailed consideration will be given to updating the plan for 2010-2011 at the mid term meeting in Moscow, April 2009.

6. IFLA Newspaper Section Conference Programmes

6a. **28**th **IFLA Newspapers Section Business meeting & Conference**: *Old Issues, New Issues: Impact of Digital Technology upon Contemporary and Historic Newspapers*. National Library of Singapore 1-3 April 2008.

Hartmut Walravens said the conference had been very well organised, with good papers and plenty of professional exchanges. The five minute presentations of the major sponsors had worked well. The papers of this conference as well as those given at the Open Session at Quebec are in the process of being edited for publication in the IFLA Publication Series. Action: **H. Walravens**. It remained to follow up the matter of recruiting more members for the Newspaper Section from those who attended. Action: **Ed King**

6b. World Library and Information Congress: 74th IFLA General Conference and Council, Quebec, August 2008. see: http://www.ifla.org/IV/ifla74/index.htm

- 1. The Newspapers Open Session is to be held on the 11 August at 1600; on the theme *The North American Ethnic Press*. Ed King thanked Sandra Burrows for the original idea for this theme, which attracted good proposals for papers. The papers are on IFLANET at session 97: http://www.ifla.org/IV/ifla74/Programme2008.htm
- 2. The intention is to have these four papers published together with the papers given at the Singapore conference, in the IFLA Saur Series, by the end of 2008.
- 6c. 30th IFLA Newspapers Section Business meeting (13 April) and Conference, Mozhaisk, 14-15 April 2009: To be held at Mozhaisk (near Moscow) at the invitation of the Russian Book Chamber. Theme of the Conference: *Legal deposit of newspapers for libraries: challenges of the digital environment*.
 - 1. the dates are to be 13-15 April 2009. The 30th Newspaper Section Business meeting will be held on the 12 April in Moscow.
 - 2. it is intended to attract delegates from Russian and CIS libraries; and from the Moscow region.
 - 3. The support of IFLA HQ for the conference is to be sought.
 - 4. A formal programme and call for papers will be issued by the middle of October.
 - 5. Papers are to be submitted by the end of December 2008. Power point presentations are to be made at the conference. Finalised papers have to be available to the organisers by the 1 May 2009.
 - 6. Translation of papers into Russian will be carried out, with these being available at the start of the conference.
 - 7. Travel and accommodation arrangements will be made available from the organisers by the end of October 2008.
 - 8. Delegates will be housed in Moscow for the night of the 12 April, before being transported to Mozhaisk on the 13 April.
 - 9. A conference registration fee will be requested of 50,00 EURO for those outside Russia. Registration is planned to close by the end of December 2008.
 - 10. The work streams for the conference are to be finalised; suggestions at this meeting were:

The current situation:

- a. How decentralised collections deal with legal deposit
- b. How to make legal deposit collections available
- c. The historical continuity of legal deposit and gaps in collections

The digital future:

- a. How to pay for digital repositories
- b. Securing publisher permissions for distribution of digitally produced material (the Singapore model)
- c. Balance between microfilm and digital collections
- d. Cataloguing of newspapers as digital objects
- 11. Ten members of Standing Committee and Observers expressed an interest in attending the Conference, and offering a paper. Action: All those who expressed an interest.
- 12. A meeting of IFLA-PAC representatives will be considered for the 10 or the 17 April
- 6d. **IFLA Satellite meeting**, **19-20 August 2009.** The Conference venue is the Royal Library, Stockholm. The theme of the Conference is to be:

"The Present becomes the past: harvesting, archiving, presenting today's digitally produced newspapers."

- 1. The target groups for the conference are: publishers, libraries, archivists, software providers. Sponsors will be sought for the conference.
 - 2. The aim is to attract 100 delegates.
 - 3. There will be a conference fee of 50 EURO.
 - 4. IFLA-PAC is to be a partner for the Conference.
 - 5. The support of IFLA HQ for the conference is to be sought.
 - 6. A formal programme and call for papers will be issued by the middle of October.
 - 7. Papers are to be submitted by the end of April 2009. Power point presentations are to be made at the conference. Finalised papers have to be available to the organisers by the 30 September 2009.
 - 8. Papers will be given in English.
 - 9. The work streams for the conference are to be finalised; suggestions at this meeting were:

The current situation of born digital production:

- a. How to preserve the daily/ weekly output
- b. Technical issues of preservation
- c. Metadata: consistency; organisation; levels of existing organisation
- d. The publisher perspective and needs
- e. The software suppliers perspectives and needs from libraries

Newspapers on the Web:

- e. Harvesting non-print newspapers
- f. What "edition" to harvest
- g. Storage of digital files
- h. Cataloguing of harvested newspapers as digital object

6e. World Library and Information Congress: 75th IFLA General Conference and Council. "Libraries create futures: building on cultural heritage" 23-27 August 2009, Milan, Italy.

After further discussion, it was agreed to widen the scope of the call for papers. This is to ensure that those most able and prepared to attend the IFLA conference are enabled to do so.

The Newspaper Section Open Programme is to be on the theme: "Newspapers in the Mediterranean and the Evolution of the Modern State". A call for papers will be issued by the end of September 2008. This them will include in its scope:

- how collections of newspapers have been formed;
- newspapers as agents of political change
- the role of newspapers in Italian unification

6f. **Spring Business meeting and conference 2010**. The possibility of holding the 32nd Business meeting and conference in Lisbon is to be explored further. Also discussed was the proposal of holding a conference in Washington D.C. (Library of Congress) in 2010, in collaboration with the IFLA Preservation and Conservation Section. The date of the conference to be determined: either in April 2009, or as a pre-IFLA Brisbane Satellite meeting.

- 1. a distributed cataloguing model was being pursued
- 2. collation of holdings continues
- 3. the records are available to all
- 4. making ICON listservs available to IFLA Newspapers Section is a future step to be done.
- 5. work is currently going on with NEWSBASNK to harvest metadata and to present it. A Forum, at the New York Public Library being held on the 23 and 24 October 2008 "On the Record..." will help build an agenda for the IFLA Satellite meeting in Stockhom
- 6. CRL is now implementing a project under the "World Newspaper Archive" banner to digitise up to one million pages of Latin American Newspapers, in cooperation with Newsbank.

Members thanked James Simon for the efforts of the Center of Research Libraries, and looked forward to further progress.

8. Membership 2008.

Ed King reported that there are currently 33 members of the Section. Further recruitment is to be actively pursued. [Later note: The Russian Book Chamber and the Bavarian State Library have become members in the meantime, which brings the count up to 35. Helsinki University Library is expected to become a member.]
