Knowledge management is about sharing knowledge with others. In the past, this was often regarded as a challenge and possible reason for poor performance of elaborate KM systems. But lately, a new way of knowledge sharing has emerged: the web 2.0. It is time for librarians and KM experts to explore this phenomenon and see what it means for the purpose of KM. **Stephen Abram**, vice president of SirsiDynix, past president of the Canadian Library Association and President-Elect of SLA (Special Libraries Association) is one of the leading visionaries of our field. He will open the session speaking about

"The Social Library: The 2.0 Phenomenon and KM" – Collaboration, Cooperation, Sharing, Storytelling, Networking"

The second speaker is **Dr. Dale Peters**, Project manager of DISA (Digital imaging South Africa), an initiative for co-operation among research libraries and archives in Southern Africa. She is a leading authority in the southern African Region in the use of digital technologies in higher education, and plays an active role in cultural heritage and research institutions. She will give a presentation on **"DISA workflow: Knowledge management in digital library operations"**

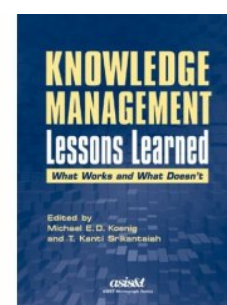

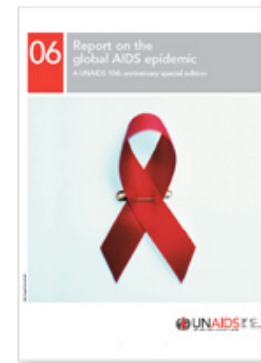

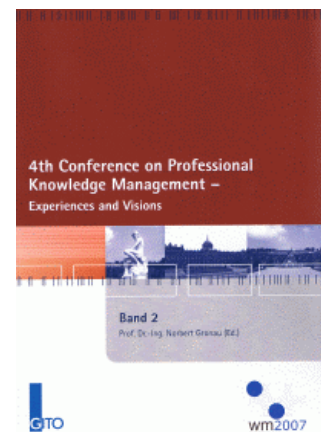
